The agency has appointed a PREA Coordinator for the Department of Corrections and Rehabilitation and a PREA Compliance Manager for the Heart River Correctional Center. Both works together to ensure compliance with every standard. Both the PREA Coordinator and the PREA Compliance Manager have the authority to develop and oversee the efforts of the facility to prevent, detect, and respond to sexual abuse and sexual harassment.

	The auditor reviewed the Heart River Correctional Center policy, the organization chart, verified the staffing levels through the staffing plan and the schedule that was provided and verified through direct observation while on the facility tour. The Heart River Correctional Center has strong leadership, a good training program, and a positive culture. There are documented, unannounced rounds conducted by intermediate and higher-level supervisors. The agency has a PREA policy that prohibits staff from alerting other staff members that these supervisory rounds are occurring, unless such announcement is related to the legitimate operational functions of the facility. There are multiple cameras throughout the facility. The facility staff includes the warden, the deputy warden/PREA compliance manager, two case managers, 11 full time and two part time residential treatment agents that work a combination of shifts from 6am to 10pm and 3 overnight security staff that work from 10pm to 6am. There are always, at a minimum, three direct care staff on duty 24 hours each day.

	This Heart River Correctional Center does not house inmates less than 18 years of age.

115.15 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Heart River Correctional Center is an all-female facility and prohibits male staff from conducting cross gender searches of female inmates. Most of the staff are female. Female inmates' access to regularly available programming is not restricted. All interviews with both inmates and staff confirmed the practice. The policy prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures as confirmed through interviews. Staff are adequately trained in cross-gender search, and such training is required by their policy. Pat searches are completed when they arrive to the campus, when returning from off-campus, and are conducted in an area with video coverage. Based on staff and inmate interviews, male staff members of the opposing gender are announced at the beginning of the shift when they will be working in the female housing area.

Inmates shower in private shower stalls with shower curtains and private toilet stalls to provide privacy and to prevent observation by staff of the opposite gender or casual observers. Some medical isolation sleeping rooms have toilets within the room and the toilet area is blocked out by a digitally placed gray box for privacy. There were three sleeping rooms in which there are cameras where inmates may be changing their clothing. Most staff assumed, and the inmates were told, that these cameras were not operational. However, they were operational without a digitally altered image where inmates may be changing clothes.

CORRECTIVE ACTIONS: To meet this standard, the auditor required that the cameras are covered or removed in the three sleeping rooms. If they are to be covered instead of removed, the administrator must promptly and clearly notify inmates when these cameras are put back into service due to use for safety and security reasons. The auditor requires photographic evidence of the covered or removed cameras. The facility provided photographs that depict a temporary cover over the cameras until a more permanent cover is installed by maintenance or the cameras are removed completely.

115.16	Inmates with disabilities and inmates who are limited English proficient

	Auditor Discussion
	The Heart River Correctional Center will provide PREA information to all inmates with disabilities including inmates who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities so that they have an equal opportunity to participate in or benefit from all aspects of facility's efforts to prevent, detect, and respond to sexual have access to use the interpretive service for all communications other than day-to-day routine communication. There were no non-English speaking inmates at the facility during the audit. The facility will provide basic PREA information verbally to inmates who are blind, those who have intellectual, psychiatric, or disabilities. They provide written information to inmates who are deaf or hard of hearing or if required, they will provide an ASL interpreter. The Heart River Correctional Center uses the Language Link, a translation service that provides interpretation for languages other than English and ASL.

115.17	Hiring and promotion decisions

	Auditor Discussion
	The auditor reviewed personnel records and staff hired over the reporting period had the required background checks. They are aware of the policy to run every five years. They are asking recent interviewees the questions required by the standard regarding any previous misconduct during the hiring process and again during the annual review/performance evaluation. In a review of files, the auditor reviewed previous institutional employer references regarding substantiated allegations of sexual abuse.

115.18	Upgrades to facilities and technologies

	Auditor Discussion
	The administrators consider the ways in which monitoring technology can enhance their efforts and abilities to protect inmates from sexual abuse through electronic monitoring and video monitoring. They added camera systems in all key areas prior to opening the facility in June 2021. The facility was previously used by juvenile corrections and no significant modifications were made since it was transferred to an adult corrections facility for women.

115.21	Evidence protocol and forensic medical examinations

	Auditor Discussion
	The administrative investigator has been trained through the North Dakota Department of Corrections and Rehabilitation investigator training on how to conduct administrative investigations. All criminal allegations are turned over to the North Dakota Highway Patrol for investigation. Victims of sexual abuse have access to forensic medical exams conducted by a SANE through Sanford Hospital. The facility has an MOU with the Abused Adult Resource Center.

115.22	Policies to ensure referrals of allegations for investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility refers all allegations for investigation. The Heart River Correctional Center investigations are completed by qualified investigators and required documentation and reporting occur. The PREA policy and the DOCR Coordinated Response Plan includes investigative policy procedure and is posted on the DOCR website at https://www.docr.nd.gov/prison-rape-elimination-act-overview. The North Dakota Highway Patrol is notified for criminal investigations. The North Dakota Highway Patrol will follow their policy 4-3 Criminal Investigations which is posted online at https://www.docr.nd.gov/prison-rape-elimination-act-overview. and will transfer those to the North Dakota Bureau of Investigation or local law enforcement in all cases involving major crimes.

115.31	Employee training

	Auditor Discussion
	PREA training with staff was apparent during the interviews as staff were very knowledgeable in the required competencies such as the correct first responder response – separate, provide care, protect evidence, call for assistance, notify shift supervisor and provide a written report. Staff were knowledgeable in how to recognize signs of sexual abuse and how to communicate effectively with LGBTI inmates. Staff participate in a classroom PREA training when they are newly hired that includes all aspects of the PREA standards. Each year they participate in an on-line PREA refresher training.

115.32	Volunteer and contractor training

	Auditor Discussion
	The facility provides PREA training to all volunteers and contractors. They have not utilized any since HRCC opened as COVID protocols did not allow for this. The auditor reviewed the training that was provided previously to volunteers and contractors at the juvenile facility to include the lesson plans and the signature sheets. The facility will train all volunteers and contractors when COVID protocols are lifted.

115.33	Inmate education

	Auditor Discussion
	The inmates receive a handbook on the day of arrival that outlines important PREA information on pages 10 to 12, and this is pointed out to them during intake. The inmate signs that they have received the handbook. There are posters posted throughout the facility. The interviews confirmed that inmates were aware of how to report and were familiar with multiple ways to report. The Heart River Correctional Center has a video to provide a more in-depth PREA curriculum for inmates that is presented within 30 days of intake and includes a small test that the inmate must take to show that they were paying attention to the information. The information is also provided in Spanish which is the language that is primarily used other than English. There is access to an interpretive service to assist for inmates who may speak a language other than English or American Sign Language. The video is subtitled, and the staff will assist in explaining information to inmates who may have other disabilities that may limit their comprehension of the information.

115.34	Specialized training: Investigations

	Heart River Correctional Center staff members who conduct investigations receive training and the curriculum meets the specialized training requirements. There is documentation of when and who received the training. The administrative investigator for the neighboring juvenile facility currently assists with administrative investigations. In addition, the PREA Coordinator, the HRCC Warden and the Deputy Warden have completed the required specialized training for administrative investigators. All criminal allegations are turned over to the North Dakota Highway Patrol who have received training for sexual abuse investigations. The auditor interviewed the criminal investigator and found him experienced addressing criminal sexual abuse investigations for the Heart River Correctional Center.

115.35	Specialized training: Medical and mental health care

	The medical for the Heart River Correctional Center complete the specialized training through NIC "PREA: Medical Health Care of Sexual Assault Victims in a Confinement Setting". The mental health staff complete the NIC course "PREA: Behavioral Health Care for Sexual Assault Victims in a Confinement Setting". The nurse and the mental health staff were knowledgeable in all aspects of the standards during the interviews.

115.41 Screening for risk of victimization and abusiveness Auditor Overall Determination: Meets Standard **Auditor Discussion** The auditor based compliance on a review of the PREA policy, the PREA Rating Assessment Manual, the inmates' PREA Score Sheet (screening document), and interviews with staff and inmates. The Heart River Correctional Center Admission, Reception and Orientation, Transfers policy 4A-01 requires intake staff to screen all offenders during the booking process but no later than 24 hours after intake into Heart River Correctional Center and before being assigned to a housing unit. The intake staff uses a screening tool which specifically asks all screening indicators as required by the to determine if the offender is at risk of future victimization or sexual abuse or is at risk of committing sexual abuse. The intake procedure requires a screening within 24 hours of arriving at Heart River Correctional Center. The screening is conducted for potential mental and physical vulnerabilities which could jeopardize safety and/or sexually aggressive behavior. The Case Manager reviews the inmate's classification status if they have been at the Heart River Correctional Center for 30 days. She examines changes in the inmate's behavior or circumstances. Inmates who are transgender or intersex are reassessed at least twice each year. Inmates are also reassessed if referred, requested by a staff member, there is an incident of sexual abuse or there is receipt of any other information that increases the inmate's risk of sexual victimization or abusiveness.

115.42	Use of screening information

	Auditor Discussion
	Heart River Correctional Center staff use the screening information to determine placement within their housing unit — ensuring that known aggressors are not placed with potential victims, and for programming while the facility. Heart River Correctional Center staff state all housing assignment are done on a case-by-case basis considering the inmate's own views of safety. All inmates shower separately from other offenders. The Heart River Correctional Center implements appropriate controls on the dissemination of responses to screening questions asked pursuant to this standard to ensure that sensitive information is not exploited to the offender's harm by staff or other offenders. During the interviews staff were knowledgeable of this PREA standard.

	Heart River Correctional Center staff find alternative housing units that provide protection for the inmate without segregating or isolating them. They do not use protective custody as means for protecting inmates from risk of sexual victimization. This was confirmed through staff and inmate interviews.

115.51 Inmate reporting Auditor Overall Determination: Meets Standard **Auditor Discussion** The auditor interviewed administrators, staff, and inmates, reviewed policy and toured the facility. The Heart River Correctional Center provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. At the time of the on-site portion of the audit the Heart River Correctional Center was utilizing the Domestic Violence Crisis Center (DVCC) as its external reporting entity as well as the North Dakota Highway Patrol. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The facility immediately took action and corrected their materials to list the rape crisis center, the Abused Adult Resource Center only under "Victim Support Services" and the North Dakota Highway Patrol as their only external reporting entity. CORRECTIVE ACTION: The auditor required that only the North Dakota Highway Patrol is listed as an external reporting

entity and all references to the rape crisis center be under the heading "Victim Support Services". The facility immediately

rectified their materials in this manner.

115.52	Exhaustion of administrative remedies

	Auditor Discussion
	The Heart River Correctional Center formal administrative procedures are in policy 3C-10 Grievance Procedure. A grievance alleging sexual abuse may be submitted using a grievance form, but it will be removed from the grievance process and processed under the PREA policy as an investigation as though it were submitted under any other PREA reporting method.

115.53	Inmate access to outside confidential support services
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Standard 115.53 Inmate access to outside confidential support services.
	Inmates have access to outside confidential support services. The facility has an MOU agreement with the Abused Adult Resource Center for advocacy services. The auditor viewed posters throughout the facility with the information on how to contact them. A resident can make a request to speak with the medical or mental health. The facility provides reasonable access to their attorneys and to their parents or legal guardians.
	CORRECTIVE ACTION: The auditor required that all policy, posters, handbooks, third party reporting information on the website and training materials be corrected to ensure that the Abused Adult Resource Center or any other victim support service is not under the heading "Reporting" but only listed under "Victim Support Services". The administrator immediately provided updated materials with the Abused Adult Resource Center listed under the heading "Victim Support Services".

115.54	Third-party reporting

	Auditor Discussion
	The facility has third-party reporting information available on their website at https://www.docr.nd.gov/prison-rape-elimination-act-overview under the heading "How to Make a Report". The HRCC not received any third-party reports.

115.61	Staff and agency reporting duties

	Auditor Discussion
	The facility requires all staff to immediately report any knowledge, suspicion or information received related to sexual abuse/harassment incidents, retaliation and staff negligence that may have contributed to such incidents. Staff are required to make such reports to the staff supervisor and a report is submitted to the investigator. Random staff interviews confirmed their responsibility to report and to maintain that information in confidence. The PREA policy requires that outside investigators be informed when there is suspected criminal activity.

115.62	Agency protection duties

	The facility requires all staff to take immediate action to protect the inmate from imminent sexual abuse. The facility has had no reported incidents over the past reporting period in which an inmate was subject to risk of imminent sexual abuse. Interviews confirmed compliance with expected practices. Administrators and direct care staff understood and agreed that "immediate" means when the response is needed – that could mean within minutes if the abuse was recent, or it could mean before the end of the shift for incidents in which an abuse was reported that occurred in the distant past.

	Interviews with the senior-level staff confirm actions that are taken upon receiving an allegation of sexual abuse while an inmate was at another facility. There was one incident reported during this past reporting period of one incident reported to another facility. The incident was properly documented.

115.64	Staff first responder duties

	Interviews with staff verified their process to provide assistance, separate alleged victim/abuser, preservation and protection of evidence by securing the scene including the request of the victim not to take any actions that could destroy any physical evidence. 	The Heart River Correctional Center has coordinated actions to be taken when an incident occurs that are outlined within their PREA policy and the DOCR PREA Coordinated Response Plan. The HRCC response plan outlines the steps to be taken at the onset by first responders, transport to the hospital and activation of the Sexual Assault Response Team (SART). The SART team consists of an advocate, certified forensic nurse examiner and specially trained law enforcement investigators that address the medical, emotional and legal needs of survivors who have been sexually assaulted. These members will report to the hospital. The inmate would be transported to the Sanford Health where SANE staff are available to conduct a forensic examination.

115.66	Preservation of ability to protect inmates from contact with abusers

	The administrators will remove alleged staff sexual abusers from contact with inmates pending the outcome of the investigation. The facility does not employ represented (union) employees. The facility is not restricted in any way from protecting inmates from contact with abusers.

	The PREA Compliance Manager is charged with monitoring for retaliation. Measures include housing changes, removing contact of alleged staff/inmate abusers and emotional support services for those who fear retaliation. 	There have been no investigations to review. There was ongoing incident of voyeurism in which the auditor discussed with the inmate and the investigative staff. A documented outcome will be reported back to the inmate at the conclusion. Through interviews with the investigator, it was determined that investigations are not terminated should the source of the allegation recant. Should criminal prosecution be considered, the investigator coordinates with the prosecutor. Polygraph tests are not used during their investigations. Administrative investigations will include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports, which will include physical/testimonial evidence, credibility assessments and investigative facts and findings. All written reports will be retained for as long as the alleged abuser is incarcerated or employed by the facility plus five years. Investigations will not be terminated due to the departure of an alleged abuser or victim. These steps are properly documented in the policy A1-27 – Criminal Investigation, Intelligence and Alleged Delinquencies.

115.72	Evidentiary standard for administrative investigations

	The facility uses no standard higher than a preponderance of evidence in making a determination of alleged sexual abuse/harassment. This was confirmed through the interviews with the investigator.

	There is one case that requires the inmate to be notified, but it had not been concluded before the audit report was completed. on. The auditor's compliance determination was made through interviews, and a review of policy and procedure. For allegations of staff sexual abuse against an inmate, they will notify the inmate when the staff member is no longer posted within the resident's unit, when the staff member is no longer employed at the facility, the alleged abuse has been indicted on a charge related to sexual abuse in the facility and if the alleged abuse has been convicted on a charge related to sexual abuse within the facility.

115.76	Disciplinary sanctions for staff

	The auditor interviewed staff and the investigator and reviewed policy. Staff are subject to disciplinary sanctions up to and including termination for violating agency sexual abuse or sexual harassment policies. Termination is the presumptive disciplinary sanction for staff who have engaged in sexual abuse. Disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than actually engaging in sexual abuse) are commensurate with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories. All terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff who would have been terminated if not for their resignation, are reported to law enforcement, unless the activity was clearly not criminal.

115.77	Corrective action for contractors and volunteers

	Contractors and volunteers are subject to disciplinary actions including termination for violation of facility sexual abuse/harassment policies.
