Prison Rape Elimination Act of 2003, policy 3C-04 contains the definitions, the agency's zero tolerance policy and references each standard and the applicable DOCR standards and documents that correspond to that standard. The agency has appointed a PREA Coordinator for the Department of Corrections and Rehabilitation and a PREA Compliance Manager for the Heart River Correctional Center. Both works together to ensure compliance with every standard. Both the PREA Coordinator and the PREA Compliance Manager have the authority to develop and oversee the efforts of the facility to prevent, detect, and respond to sexual abuse and sexual harassment.</p>

	<p>The auditor reviewed the Heart River Correctional Center policy, the organization chart, verified the staffing levels through the staffing plan and the schedule that was provided and verified through direct observation while on the facility tour. The Heart River Correctional Center has strong leadership, a good training program, and a positive culture. There are documented, unannounced rounds conducted by intermediate and higher-level supervisors. The agency has a PREA policy that prohibits staff from alerting other staff members that these supervisory rounds are occurring, unless such announcement is related to the legitimate operational functions of the facility. There are multiple cameras throughout the facility. The facility staff includes the warden, the deputy warden/PREA compliance manager, two case managers, 11 full time and two part time residential treatment agents that work a combination of shifts from 6am to 10pm and 3 overnight security staff that work from 10pm to 6am. There are always, at a minimum, three direct care staff on duty 24 hours each day.</p>

	This Heart River Correctional Center does not house inmates less than 18 years of age.

	<p data-bbox="240 210 453 235"><b>Auditor Discussion</b></p> <p data-bbox="240 271 1481 533">The Heart River Correctional Center is an all-female facility and prohibits male staff from conducting cross gender searches of female inmates. Most of the staff are female. Female inmates' access to regularly available programming is not restricted. All interviews with both inmates and staff confirmed the practice. The policy prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures as confirmed through interviews. Staff are adequately trained in cross-gender search, and such training is required by their policy. Pat searches are completed when they arrive to the campus, when returning from off-campus, and are conducted in an area with video coverage. Based on staff and inmate interviews, male staff members of the opposing gender are announced at the beginning of the shift when they will be working in the female housing area.</p> <p data-bbox="240 562 1485 757">Inmates shower in private shower stalls with shower curtains and private toilet stalls to provide privacy and to prevent observation by staff of the opposite gender or casual observers. Some medical isolation sleeping rooms have toilets within the room and the toilet area is blocked out by a digitally placed gray box for privacy. There were three sleeping rooms in which there are cameras where inmates may be changing their clothing. Most staff assumed, and the inmates were told, that these cameras were not operational. However, they were operational without a digitally altered image where inmates may be changing clothes.</p> <p data-bbox="240 786 1481 949"><b>CORRECTIVE ACTIONS:</b> To meet this standard, the auditor required that the cameras are covered or removed in the three sleeping rooms. If they are to be covered instead of removed, the administrator must promptly and clearly notify inmates when these cameras are put back into service due to use for safety and security reasons. The auditor requires photographic evidence of the covered or removed cameras. The facility provided photographs that depict a temporary cover over the cameras until a more permanent cover is installed by maintenance or the cameras are removed completely.</p>

There were no non-English speaking inmates at the facility during the audit. The facility will provide basic PREA information verbally to inmates who are blind, those who have intellectual, psychiatric, or disabilities. They provide written information to inmates who are deaf or hard of hearing or if required, they will provide an ASL interpreter. The Heart River Correctional Center uses the Language Link, a translation service that provides interpretation for languages other than English and ASL.</p>

In a review of files, the auditor reviewed previous institutional employer references regarding substantiated allegations of sexual abuse.</p>

They added camera systems in all key areas prior to opening the facility in June 2021. The facility was previously used by juvenile corrections and no significant modifications were made since it was transferred to an adult corrections facility for women.</p>

The North Dakota Highway Patrol is notified for criminal investigations. Staff were knowledgeable in how to recognize signs of sexual abuse and how to communicate effectively with LGBTI inmates. Staff participate in a classroom PREA training when they are newly hired that includes all aspects of the PREA standards. Each year they participate in an on-line PREA refresher training.</p>

The inmate signs that they have received the handbook. There are posters posted throughout the facility. The interviews confirmed that inmates were aware of how to report and were familiar with multiple ways to report. The Heart River Correctional Center has a video to provide a more in-depth PREA curriculum for inmates that is presented within 30 days of intake and includes a small test that the inmate must take to show that they were paying attention to the information. The information is also provided in Spanish which is the language that is primarily used other than English. There is access to an interpretive service to assist for inmates who may speak a language other than English or American Sign Language. The video is subtitled, and the staff will assist in explaining information to inmates who may have other disabilities that may limit their comprehension of the information.</p>

There is documentation of when and who received the training. The administrative investigator for the neighboring juvenile facility currently assists with administrative investigations. In addition, the PREA Coordinator, the HRCC Warden and the Deputy Warden have completed the required specialized training for administrative investigators. All criminal allegations are turned over to the North Dakota Highway Patrol who have received training for sexual abuse investigations. The Heart River Correctional Center Admission, Reception and Orientation, Transfers policy 4A-01 requires intake staff to screen all offenders during the booking process but no later than 24 hours after intake into Heart River Correctional Center and before being assigned to a housing unit. The intake staff uses a screening tool which specifically asks all screening indicators as required by the to determine if the offender is at risk of future victimization or sexual abuse or is at risk of committing sexual abuse. The intake procedure requires a screening within 24 hours of arriving at Heart River Correctional Center. The screening is conducted for potential mental and physical vulnerabilities which could jeopardize safety and/or sexually aggressive behavior. The Case Manager reviews the inmate's classification status if they have been at the Heart River Correctional Center for 30 days. She examines changes in the inmate's behavior or circumstances. Inmates who are transgender or intersex are reassessed at least twice each year. Inmates are also reassessed if referred, requested by a staff member, there is an incident of sexual abuse or there is receipt of any other information that increases the inmate's risk of sexual victimization or abusiveness.</p>

	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1485 495">Heart River Correctional Center staff use the screening information to determine placement within their housing unit – ensuring that known aggressors are not placed with potential victims, and for programming while the facility. Heart River Correctional Center staff state all housing assignment are done on a case-by-case basis considering the inmate’s own views of safety. All inmates shower separately from other offenders. The Heart River Correctional Center implements appropriate controls on the dissemination of responses to screening questions asked pursuant to this standard to ensure that sensitive information is not exploited to the offender’s harm by staff or other offenders. During the interviews staff were knowledgeable of this PREA standard.</p>

	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1493 831">The auditor interviewed administrators, staff, and inmates, reviewed policy and toured the facility. The Heart River Correctional Center provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. At the time of the on-site portion of the audit the Heart River Correctional Center was utilizing the Domestic Violence Crisis Center (DVCC) as its external reporting entity as well as the North Dakota Highway Patrol. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The facility immediately took action and corrected their materials to list the rape crisis center, the Abused Adult Resource Center only under "Victim Support Services" and the North Dakota Highway Patrol as their only external reporting entity.</p> <p data-bbox="244 864 1453 958"><b>CORRECTIVE ACTION:</b> The auditor required that only the North Dakota Highway Patrol is listed as an external reporting entity and all references to the rape crisis center be under the heading "Victim Support Services". The facility immediately rectified their materials in this manner.</p>

	The Heart River Correctional Center formal administrative procedures are in policy 3C-10 Grievance Procedure.
